INTRODUCTION

A case can take a long time to complete and during that period different levels of Court Fees and Hourly rates would have been applied. When reviewing a claim for costs in such a case it is essential that you have access to the historical information in order to check whether the correct fee has been paid or if there may have been an entitlement to exemption.

We have provided links to the EX50 Court Fees leaflets for 2007, 2011, 2014, 2015, 2017 and 2020 at present. If anyone has PDF copies of any additional leaflets published since 2008 please forward to enquiries@costslawyer.co.uk so that we may add them to this page. These leaflets are often considered a good research source when considering the relevant Court Fees.

It is however necessary to have the authorities available for consideration at a hearing so we have gathered together links to the legislative sources for the fees which we hope you will find useful. The starting point for this note is 2008.
